Introduction -

This Quick Guide contains start-up instructions for installing and operating Vood IP Residential gateways, models 452, 452w and 453w. These Vood devices connect regular analog touch-tone telephones and your computer to IP-based networks. The **w** models add wireless functionality to the home LAN. The Vood gateways are installed on the customer premises.

Delivered with the Gateway Unit -

Confirm that you have received the following:

- A Vood gateway model 453w_A, 452w_A or 452_A
- W models should be delivered with antennae
- AC/AC Adapter 12VOUT EU 1200 mA
- 1 RJ-11 cable grey 1.8m
- Ethernet cable yellow straight UTP CATS 1.8m
- 1 Quick Guide (this document)
- Gift Box Vood 4XX

Your DSL service provider might also include:


- In-line filter(s)
- Wall-mount wall filter
- Two-to-one adapter
- Country-specific phone plugs.

Installing the Vood IP Residential Gateways -

- 1. Check your delivery against the list above.
- 2. Install any necessary filters or adapters.
- 3. Prepare your PC for connection to the Vood Gateway.
- 4. Set up the Vood Gateway and its connections.
- 5. Configure the Vood Gateway.

Installing filters and adapters -

All devices (phone, fax machine, caller ID box, etc.) that share the phone line with the Vood require splitters. There are 2 kinds of filters: in-line or wall-mounted. **Do not install** a splitter on the phone line that goes to the Vood.

In-Line Filters.

For each device that shares the phone line with the Vood, you must add a filter between the phone jack and the device. To install an in-line filter:

- 1. Unplug the device's cord from the phone jack.
- 2. Plug the in-line filter into the phone jack.
- 3. Plug the phone cord into the in-line filter.
- 4. Make sure the phone, fax machine, caller ID box, or other device still works.

Wall-Mounted Line Filters.

In the case of a wall-mount phone, install the wall-mount filter between the wall-mount plate and the phone. To install the wall-mount filter:

- 1. Remove the phone.
- 2. Connect the wall-mount filter to the wall plate.
- 3. Reconnect the phone.
- 4. Make sure the phone still works.

Two-to-One Adapters.

If your gateway and a telephone device are going to share the same phone jack, use a two-to-one adapter. In-line filters should only be connected to two-to-one adapters after the two-to-one adapters have been installed. To install the two-to-one adapter:

- 1. Unplug the telephone device (phone, fax machine, caller ID box, etc.) from the phone jack.
- 2. Plug the adapter into the phone jack.
- 3. Plug the in-line filter into one of the two sockets of the two-to-one adapter. The other socket will be used for the DSL cable.
- 4. Plug the telephone cord into the in-line filter.
- 5. Make sure the phone, fax machine, caller ID box and other devices work.



Prepare Your Computer -

Your PC must be configured properly to be able to surf the Internet. The PC's network card and network properties must be configured to obtain an IP address from the unit's built-in DHCP server.

Configuring the PC -

Before connecting your computers to the Vood, make sure that the network configuration is set to TCP/IP protocol and that the IP address is obtained automatically.

Depending on the operating system, you might have to reboot the computer after changing the network configuration. Consult the documentation provided with the computer if a problem arises.

Ethernet Installation -

You should make sure your computer supports an Ethernet adapter. If your computer does not already have one installed, you may want to install an adapter or use the wireless LAN installation method.

To connect the Vood to the PC's Ethernet port:

- Connect the Ethernet cable to one of the Ethernet ports on the Vood.
- 2. Connect the other end of the Ethernet cable to the Ethernet port on your computer.
- 3. Plug the DSL cable (phone line) into the DSL port on the Vood. If you are using a two-to-one adapter, plug the DSL cable into the unused socket.
- 4. Plug the power adapter into the power outlet and the Vood.
- If the Power LED does not come on, make sure the Vood is turned on.
- 6. Power on the PC. Your Vood's Ethernet light will come on if everything is connected correctly.



Wireless LAN (WLAN) Installation (w models only) -

Make sure your computer supports a WLAN adapter. If your computer does not already have one installed, you may choose to install one or you may choose to use a cabled Ethernet connection.

To connect the Vood to the PC's WLAN port:

- 1. Install the Vood antenna if it's not already installed.
- 2. Plug the DSL cable (phone line) into the DSL port on the Vood. If you are using a two-to-one adapter, plug the DSL cable into the unused socket.
- 3. Plug the power adapter into the power outlet and Vood.
- 4. If the Power LED does not come on, make sure the Vood is turned on.
- 5. Power on the PC Your Vood WLAN light will flash if everything is functioning correctly.

Configuring WLAN Cards for Windows Machines

Your wireless LAN card should be packaged with a profile configuration utility. Install and run this utility. It will guide you through configuring your WLAN card and connecting to the Vood gateway.

If you have received instructions from your service provider regarding WLAN security level settings, you should follow these instructions when running the profile configuration utility.

WLAN cards currently available have numerous options; if the instructions provided with the WLAN card fail, and/or your service provider does not recommend specific WLAN settings, use the default Vood WLAN port settings below. They will determine the configuration.

Enter these values if you are prompted to do so by the profile configuration utility:

- SSID for 453w = Tilgin-IAD453W
- SSID for 452w = Tilgin-IAD452W
- Beacon Period = 200

- DTIM Period = 2
- RTS Threshold = 2347
- Frag Threshold = 2346
- Power Level = Full
- B/G mode = Mixed
- Wireless Security level = None

After you have saved the new WLAN profile you should make sure your PC's network settings are configured properly. See below for more details.


Network Settings for MAC 7.6 and Above

- Locate the Control Panel menu and select TCP/IP.
- Locate the Connect menu and select Ethernet.
- Locate the Configure menu and select Fixed IP address.
- Enter an address within the 192.168.1.2 to 192.168.1.255
 range (i.e. 192.168.1.100). All other fields should be blank.
- Close the TCP/IP Control Panel.
- Click Save to save the current configuration.

Network Settings for Windows-based Machines-


For Windows-based machines, follow the procedure below. This procedure applies to both cabled Ethernet and WLAN installations.

- Right click on the Network Neighborhood or My Network Places icon on the desktop.
- 2. Select **Properties** from the menu.



- 3. If multiple network connections are available on the PC, right click on the **Local Area Connection** (for a cabled Ethernet installation) or Wireless Network Connection (for a WLAN installation) and select Properties.
- 4. Select the **General** tab.
- Identify the TCP/IP -> network card entry. If there is no entry, then something has not been installed properly.

Highlight the TCP/IP -> network card entry.



- 7. 7.Click Properties.
- 8. 8.Click Obtain an IP address automatically.
- 9. Click the **OK** button and close the dialog box. Then click the **OK** button again to save the changes and exit Network Properties.
- 10. Restart your PC.

Install the Vood 452, 452w or 453w and its Connections

When the computer is properly configured it can be connected to the Vood by means of either an Ethernet cable with an RJ-45 connector or a WLAN link. The Ethernet cable should be connected to a port marked LAN A, LAN B, LAN C or LAN D [#4 on the **Interfaces** page].

The other end of the cable should be connected to the Ethernet network interface of the PC.


Note: Connect your PC to only one interface of the Vood (cabled Ethernet or WLAN).

Check that the LAN connector green light on the Vood is lit [it is # 4 on the Interfaces page].

Proper Placement of the Vood Unit

Gateways should always be installed away from heat sources and direct sunlight. Gateways and power supplies are electrical devices that can overheat without ventilation. Do not cover or crowd them with objects or clothing that prevents good ventilation.

Vood cable attachments





Each outlet and its connected cable will be color coded as indicated above. Either of the two telephones displayed above may be replaced by a fax machine.

Connecting Voice Over IP Telephones

If you have a subscription for IP telephony with your service provider, you can connect touch-tone telephones to the two phone ports [# 3 on the **Interfaces** page]. Each port can handle up to five telephones in cascade. Use telephone cables with RJ-11 connectors.

Note: Do not connect either of the two Vood 453W phone ports to a telephone wall jack; this might damage the device or other telephone network equipment.

Standard Telephone Service Using the Vood Line Port

The Line Port connection [# 2 on the Interfaces page] on the back of the Vood unit uses a standard telephone cord to link to a standard (PSTN) telephone line. It is designed to provide backup standard service for the telephone lines connected to Phone 1 and Phone 2 ports [# 3 on the Interfaces page] in the event that the unit's IP connection fails. The extent to which this backup service is available has been determined by your provider.

Once this connection has been properly installed you do not need to do anything different for this feature to be in effect.

Front Panel LEDs

The LED lights on the front panel indicate the status of power and connections to the Vood gateway. Please see the following table for an explanation of what the LEDs indicate.

Configure the Vood IP Residential Gateway

The Vood is designed to be a plug & play device when preconfigured and managed by your service provider. However, the level of configuration needed can vary from completely plug & play to full manual configuration, depending on what your service provider offers. Follow any specific configuration instructions you may have received from your service provider.

Connecting to the Network

There are several options available for configuring the Vood. The method that has been chosen depends on the network layout and the IP telephony service providers' network. Different methods involve different levels of user interaction. The method described in this guide is the automatic provisioning method.

Note: If your service provider has chosen some other configuration method, they will have provided specific instructions regarding the configuration procedures and settings.

Automatic Provisioning

The Vood 400 series will automatically attempt to establish a connection to your service provider. If the device has been properly connected, an automatic configuration will begin.

The Vood is pre-loaded with software but at this stage a check is performed to determine if there is newer software available. If there is, it will perform a software upgrade procedure. The software upgrade procedure may take a couple of minutes.

- Connect the power cable to the power connector [# 7 on the Interfaces page] on the back of the unit. Plug the power supply adapter into a power source.
- Check that the power LED on the front panel is lit.

The software upgrade procedure may take a couple of minutes and during this time the status LED on the front panel will either be out or flashing. When the status LED is steady, the unit is operational.

If the status LED on the device never stops flashing, contact your service provider.

Troubleshooting Tips

- When no green light is seen on the WAN connector after connecting to the ADSL port [# 1 on the Interfaces page], check that the power cord is properly connected.
- If you do not hear a dial tone after hook off on the telephone handset, check that the telephone line cord from the telephone is connected to the unit.

If these actions do not solve the problem, contact the service provider or vendor that supplied your Vood Gateway.

If you want to mount your product on a wall, you can use the drill guide in this manual for drilling correctly spaced holes. The template shows an outline view of the product with two indicated drill locations.

- 2. When you have measured the correct distances onto your wall, drill two holes and insert two suitable screws.




